Description

Component Sourcing International, LLC (CSI) is a Strategic Sourcing company which manufactures custom metal components in the following 5 product categories: 1) Precision screw machine parts, 2) Castings, 3) CNC Machined parts, 4) Fabricated metal components and 5) Assemblies. CSI's services are primarily targeted to medium-sized companies which do not have the in-house resources, capabilities, or expertise to properly analyze and implement international sourcing strategies. The company has an outstanding reputation for responsiveness and quality.

CSI is seeking a Supplier Quality Engineer to manage a portion of the rapidly increasing demand for the company's products and capabilities. Responsibilities include: 1) Engineering analysis and support for specific component projects from initial inquiry to production, 2) Serving as a liaison between customers and suppliers for engineering issues, 3) Plan and oversee secondary operations and rework of production parts when needed 4) Lead auditor for the company's ISO 9001 system; issuing and tracking all non-conformances and corrective actions. 5) Managing Asia-based QC and engineering team schedule for supplier qualification visits, in-line and final inspection of parts, 6) Sampling and PPAP documentation management.

CSI offers outstanding growth potential and seeks a highly motivated individual with excellent mechanical and organizational skills. The desired candidate should feel comfortable in a manufacturing setting and have Solidworks or CAD computer skills. Requirements include a B.S in Mechanical Engineering or equivalent educational or work experience and at least 3 years experience. Foreign language competency is a plus. The Supplier Quality Engineer will receive a competitive salary and benefit package, international exposure and travel, and opportunities for further education.

Requirements

1. Develop and implement Supplier Quality processes and systems that will drive improvement in the external supply chain to reach target of 400 ppm.
2. Plan, organize, direct and perform all supplier quality related activities within supply chain team, including identification of risk and mitigation.
3. Assist suppliers in quality assurance processes and procedures to facilitate continuous improvement of supplier and product performance.
4. Perform and/ or participate in source qualification by performing quality and manufacturing systems surveys and special process surveys.
5. Provide trouble shooting with supplier and remote staff to resolve issues as required. Review and approve SCAR responses to supplier quality issues and verify the effectiveness of supplier actions on subsequent product inspections/ receipts/visits.
6. Collaborate with suppliers and remote staff to complete PPAP documentation including cpk studies and other statistical requirements are completed.
7. Develop and maintain supplier quality metrics.
8. Perform internal quality and process audits to ensure ISO 9001 and QS 9000 compliance.
9. Work with purchasing and project management by participating in design reviews and validating supplier capabilities to part requirements.
10. Interact routinely with clients, internal and remote staff, and suppliers to proactively improve the quality of components.
11. Lead the non conforming material review board (NCMR) and facilitate corrective action and Manage the internal Corrective Action Preventive Action (CAPA) process and system.
12. Develop and maintain good relationships with suppliers and clients to facilitate retention of business.
13. Support and demonstrate the core values of the organization: integrity, respect, professionalism, enthusiasm, and teamwork.
14. Performs special projects including design work where needed, as well as other duties as defined by management.
